PROPOSITION

- 1. Croatian Football Club "RIJEKA", Rijeka is the organizer of the 70. International Youth Football Tournament "KVARNERSKA RIVIJERA 2024"
- 2. The tournament starts on 27.05. and ends on 01.06. 2024.
- 3. There are 16 clubs participating in the tournament.

SUB-COMPETITION IN GROUPS

- 4. Clubs for pre-competition matches are arranged by four (4) clubs in four (4) groups. All group matches are played under a single point system, each club against each. Three (3) points are awarded for the win and one (1) point for a draw. According to the special official program of the tournament, group matches are played on playgrounds in various parts of the Kvarner Riviera and Istria:
- 1. ROUND Monday 27.05. 2024.
- 2. ROUND Tuesday 28.05, 2024.
- 3. ROUND Wednesday 29.05. 2024.
- a) Clubs that win first place in groups acquire the right to compete for the first and third place in the tournament.

.

If two or more clubs score the same number of points, preference is given to the club that scored better in the match against each other. In the event that the head-to-head match was undecided, the winner is the club that has a greater goal difference between goals scored and conceded.

If it happens that the clubs are equal in all cases, the winner of the group will be decided by draw.

FINAL COMPETITION

5. Matches of the final competition between the clubs of the winners of the group are played:

THURSDAY - day off 30.05.2024.

SEMIFINALS - Friday 31.05.2024. (winner of Group A - winner group D / winner group B - winner group C )

FINAL - Saturday 01.06. 2024. at 15:00h

If a match in the final competition ends in a draw, five penalties are taken.

If no winner is obtained even then, the performance of the shots continues until the decisive goal is scored and the winner is determined.

PENALTY KICKS

6. Each team takes five (5) penalty kicks alternately with each penalty kick from 11 yards taken by a different player. Which team will start taking the penalty kick first is decided by draw.

Only players who were in the game at the end of the regular course of the match 2x40 minutes of play participate in penalty kicks.

The winner is the club that, after taking five (5) shots from 11 meters alternately with other players, each takes one (1) penalty kick until the final decision on the winner.

RIGHT TO PERFORM PLAYERS

- 7. Players born on January 1, 2007 and younger can play at tournament matches.8. For tournament matches, each club can register a maximum of twenty (20) players. Clubs before the start of the first match in the tournament are obliged to submit to the delegate of the match:
- a) a list of players with whom they will participate in the tournament,
- b) sports cards,
- c) identity card or PASSPORT.

The list includes: First and last name and ID number.

The list is signed by the responsible face of the club and the captain of the team .

- 9. Each player must have an Identity Card in addition to the sports card, and players of foreign clubs must have a passport or Identity card. From these documents, identity is established.
- 10. During the match, all players present on the bench can be replaced in three time periods.

DURATION OF THE MATCH

- 11. Each game lasts 2x40 minutes without extra time.
- 12. Teams are obliged to perform on the field at the exact time specified by the official tournament program. Eventual non-performance will be considered a departure from the competition and a loss of the match with 3:0 without a fight.

REFEREES

13. The main and assistant referees for all matches are determined by the "CFF Football Referees Commission".

PENALTIES

14. A player with two /2/ yellow card is also punished with one match of non-play. One game of non-play is also punishing a player who received a red card in the match. An excluded player (red card) for a serious offence may be punished with a higher penalty, which is decided by the Disciplinary Referee appointed by the Tournament Commission. The penalty in all three cases relates to not playing at the next match of the tournament.

APPEAL

15. An appeal may only be lodged in the cases referred to in points 7,8,10 and 14. "Tournament proposition".

Decisions of the referee may not be appealed, except in cases where there is a material violation of the Rules of the Football Game and the Decision of the "International Council", regulated by the Regulations on Football Competitions of the CFF. The appeal is dealt with by the Tournament Commission. The decision of the Tournament Commission is final.

TOURNAMENT COMMISSION

- 16. The tournament is managed by a commission of five (5) members:
- one member representative of the Croatian Football Federation-Branko Kajfeš
- one member representative of the Football Association County of Primorje Gorski Kotar Rijeka **Mladen Ivančić**
- one member representative of football referees- $\textbf{Vedran Jelen}\check{\textbf{c}}\check{\textbf{c}}$
- two members representatives of the club of tournament organizers- (Dragan Meić), (Denis Conte)

Clubs that have accepted participation in the tournament undertake to comply with the Decisions of the Tournament Commission.

17. If a case occurs in the tournament that is not foreseen in these Propositions, the Tournament Commission shall be authorized to make an interpretation which shall be deemed to be a supplement to these Propositions.

18. The club of the tournament organizers pays the participating clubs:

a/ accommodation costs and food for 25 persons + driver

b/ all clubs participants of the tournament bear the costs of travel to the venue where they perform and back to their seats.

19. Clubs that have accepted participation in the tournament must arrive at the place where they play in the group on 26.05. 2024. (with dinner)

Clubs that qualify for the semifinals leave the hotel on 30.05.2024. after breakfast to the place and hotel where the semi-final matches are played, and also the clubs that drop out of further competition leave the hotel on 30.05.2024 after breakfast.

The club that travels later than is foreseen in this point proposition, bears during that time all the costs incurred by accommodation and food.

- 20. The tournament organizer is not responsible for any accidents of players occurring during the match. Clubs are obliged to provide the player against possible various injuries and accidents. The organizer does not bear any possible costs for damage and treatment of the player.
- 21. Matches will be played according to the rules of the International Football Federation BOARD (IFAB)-edition 1997.) As long as no article describes anything else.
